The term of the Committee shall be for period of one year **with effect from 9th September, 2026** or till a new Committee is constituted in accordance with the Rules.

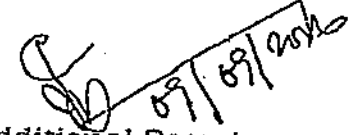
